## **A Favourite Winter Visitor**

It seems more often now than before every winter our Thousand Islands are becoming a destination for a popular northern resident, the Snowy Owl.

The Snowy owl is one of Canada's most easily recognizable owls due to its white plumage. You can also tell the difference between a male and female Snowy by their plumage. The male species is almost entirely white, while the female Snowy has feathers barred with dark brown.

Another reason why the Snowy owl is popular with birders and wildlife photographers is that the snowy owl is diurnal meaning it actively hunts during the day rather than at night. This bird of prey is a great judge of distance which allows it to swoop down and catch its prey. The circle of feathers surrounding its eyes helps reflect sound to its ears, a feature that comes in handy when vision is limited.

Numbering close to 30,000 in North America, the Snowy owl is not considered at risk in Canada. They normally reside year round in the Arctic and, breed in the northern tree line. They are known to migrate south in search of food and that is what brings them to our area. The Snowy Owl by weight is the largest of our owls. They are monogamous and mate for life. Their nest, a simple scrape on the ground, is usually positioned in a raised area such as a hummock or boulder that provides a good lookout spot. The birds aggressively protect their nest and young against intruders such as gulls, foxes, and wolves.

The female Snowy, whose mottled plumage provides good camouflage against the tundra, takes on all the egg incubation and chick care, while the male brings food to the nest. In lean lemming years, a pair may not produce any offspring at all but during lemming population booms Snowy Owls can raise broods that are several times their normal size, sometimes laying up to 11 eggs. This is another example as to how interconnected our wildlife is and why it is important to understand the relationships between species and their environment.







### **Membership Tax Receipts**

Something new for 2022 – membership dues in TIA will now receive a tax receipt! The TIA Board investigated how to make membership dues in TIA tax deductible for your personal tax returns. This applies to both Canadians and Americans.

The Thousand Islands Association for the Preservation of Water Quality Inc. and the Thousand Islands Association, Inc., collectively known as TIA, are not-for-profit corporations with charity registration status in both Canada and the United States, respectively. Memberships can qualify to receive a tax receipt provided the member does not receive a tangible benefit.

Previously TIA surveyed the membership about the free AGM breakfast which would be considered a tangible benefit. A number of replies noted it was not essential to supporting TIA as a member and many do not attend the AGM and enjoy the benefit.

Due to COVID-19 and the border closure, TIA has experienced a 25% decrease in membership renewal. During this time TIA has had two virtual AGMs without a breakfast. We are hopeful for an in-person AGM this year but upon investigating the cost of food and catering we find the breakfast has become unaffordable without increasing membership dues.

Therefore, in the interest of TIA sustainability, the free breakfast needs to be removed as a benefit in 2022 and replaced with a user pay option.

When you renew online be sure to choose Canadian Membership if you are a Canadian Citizen and choose American Membership if you are an American citizen. This allows our database to correctly identify you with the proper tax receipt.



Water Levels 2022 Mid-Winter Update, Ice Formation Status & 6-Month Forecast TIA Water Levels Committee (1/20/22)

#### During the winter the IJC's ILOSLR Board has two major jobs:

- Regulate water levels on LO & SL River according the regulation Plan 2014, balancing interests across the water basin. *Ideally* levels would be maintained *low enough* to handle high spring flows, yet *high enough* so we emerge at or above average after the "spring uncertainty mist clears".
- 2. River housekeeping to ensure formation (and survival) of stable, smooth ice sheets so flows can be adjusted at will, while preventing ice jams and flooding.



#### Observations

- January began as a dry month, however with the significant storm that developed over the region January 16th, the monthly precipitation appears to be on par with January averages. The rest of the Great Lakes (GL) remain dryer than average.
- Lake Erie/Huron and Michigan continue to have average water levels trending down. In fact Lake Erie is a full two feet lower than in 2020. Ultimately this means lower GL flows into Lake Ontario and thus lower levels in the Thousand Islands.

# MEMBERS-AT-LARGE ADVISORY GROUP A Volunteer Opportunity Peter Fitton and Jim Côté

As part of building the TIA Governance model, the Board has considered the importance of engaging its membership with representative voices along its vast territory of the river community –85 km from Kingston to Brockville running parallel to Save the River's shoal marker territory from Cape Vincent to Ogdensburg.

The Board recognizes the many mainland and island group neighborhoods that unify TIA's territory. Yet TIA is run by a Board of only up to twelve volunteer Directors that are spread thin. We believe a solution to bridge the gap is to create a Members-at-Large Advisory Group of volunteer members resident in these neighborhoods.

Members-at-Large can be invaluable to the TIA Board and the Association as a whole. Their varying interests, assignment roles, and experience on the river can help influence and make great contributions to TIA achieving its goals. They can also help improve on the engagement of the general TIA membership in TIA mission programs within the river community.

A Member at Large volunteer need not attend Board Meetings or have any regular scheduled participation in TIA affairs. A Member at Large may be asked to collaborate with a Committee Chair and serve as a liaison between a committee and the river community, possibly in the river neighborhood where the Member at Large resides, to relay information to and from the river community. Members at Large, over time and depending on their willingness and interest, may fill the role of vacant Committee Chair or Board positions.

There is no fixed term minimum or maximum for this volunteer position. It is intended to be an enjoyable experience among friends in the community who wish to share their love for the river. Members at Large may determine their own time commitment as it suits them.

The Alliance for the Great Lakes: Protecting Water, Sustaining Life

The Great Lakes and St. Lawrence River are massive and awe-inspiring. But if we don't take care of them, they are at risk from issues like invasive species, plastic pollution, and toxic algal blooms.

The Alliance for the Great Lakes is a nonpartisan nonprofit working to protect our region's most precious resource: the fresh, clean, and natural waters of the Great Lakes. With headquarters in Chicago and staff in Ohio, Michigan, New York, and Wisconsin, their team develops fact-based policy solutions, advocating for Great Lakes protection policies at regional and local levels. The Alliance works primarily in the United States but coordinates closely with Canadian nonprofits and government agencies.

The Alliance takes three connected approaches to protect the lakes:

- **Advocacy & Leadership** The Alliance partners with communities and decision-makers to develop actionable solutions that protect the lakes and our communities. As an example, the Alliance is a leader in the campaign to stop invasive carp from reaching the Great Lakes. And, the Alliance fought to secure federal funding to fix the region's crumbling water infrastructure, which will reduce sewer overflows and protect drinking water in communities in all eight Great Lakes states.
- **Education & Action** Through action-oriented information and programs, the Alliance empowers people and communities to protect the lakes. Their Adopt-a-Beach volunteer program involves nearly 15,000 volunteers each year in shoreline cleanups that keep litter, most of it plastic, out of the lakes. Volunteers also collect valuable data that provides scientists and policymakers with critical information about plastic pollution.
- **Research & Analysis** The Alliance is a trusted, non-partisan source of information to inform community leaders and guide policy to protect the Great Lakes. As an example, each year, the Alliance releases its annual federal legislative priorities. The list outlines a federal Great Lakes policy agenda and identifies the next steps Congress should take to protect the lakes. The Alliance will release its 2022 federal priorities via a public webinar on February 3.
