

TIA members should take pride in knowing that their dues make this program possible on both sides of the border. For those who have not yet joined or renewed, please do so now. Thank you.

Let's talk about our members. Who are they and from where do they come. Well, they are lawyers, judges, professors, dentists, doctors, builders, business men and women, teachers, web designers, nurses, artists, landscapers, photographers, television executives, fishermen, detectives, boat designers, carpenters, plumbers, social media consultants, scientists, grant writers and so many more professions. Due to COVID 19 and the ongoing restrictions on large gatherings imposed by our government and health officials, the TIA Annual General Meeting (AGM) will not take place as customary at the Thousand Islands Playhouse facilities in Gananoque, Ontario, Canada. In accordance with the By-Laws of the Thousand Islands Association for the Preservation of River Quality Inc. (Canada) and The Thousand Islands Association Inc. (USA) collectively and hereinafter referred to as "TIA", this serves as notice from the Board of Directors of TIA that the 2021 Annual General Meeting (AGM) of the Association will be held in two parts:

#### **PART ONE**

#### JULY 5 to JULY 20, 2021 - DOCUMENTS REVIEW AND SURVEY MONKEY VOTING:

Matters of TIA business requiring formal approval will be managed by sending copies of documents and motions to the general membership for review, discussion and then voting on Survey Monkey. Motions to be addressed include: Approval of the 2020 AGM Minutes; Approval 2020 Financial Statements for Canada and USA; Approval of Auditors for 2021 Fiscal Year End (FYE); and Election of Directors for 2021 / 2022 term.

On July 5, 2021 Survey Monkey will be turned on and TIA will request the membership to participate in voting on the motions with a response deadline of July 20, 2021.

#### **PART TWO**

#### **JULY 24, 2021 - ZOOM AGM:**

The fellowship aspect will be managed online comprised of meet & greet sessions opening at 9:00 EDT followed by welcomes from local government dignitaries and then starting at 10:00 EDT remarks from TIA President, Results of PART ONE DOCUMENTS REVIEW & MONKEY SURVEY VOTING, Introduction of Board of Directors, TIA Committee Report Updates, and Speaker Presentations.

Note pursuant to TIA By-Laws Article VII, and in line with the structure of the AGM proceedings outlined above, the business meeting is considered to start on July 5, 2021. Accordingly, and pursuant to By-Laws Article VI, proposals by members may include nominations for the election of Directors if the proposal is signed by not less than then (10) members entitled to vote at the meeting provided it is delivered and received by the Secretary of the Corporation by mail or electronic communication at least seven (7) days prior to the date of the meeting and election, deadline therefore being June 28, 2021.

# The Great Lakes Foundation For Their Generous Grant



The Great Lakes Foundation is an affiliate of the Great Lakes Cruising Club (GLCC). We are a charitable organization dedicated to preserving the richness of wilderness cruising areas of the Great Lakes and fostering the art and science of cruising. All members of the GLCC are automatically members of the Great Lakes Foundation and participate in its affairs.

The Foundation has awarded more than \$250,000 USD in grants since 1993 to activities that meet the Foundation's Grant Policy. This year, the Foundation was pleased to award a grant of \$8800 USD in support of the TIA Shoal Marker Program.

The GLCC was founded in 1934 (the same year as the TIA!) and is a non-profit organization of about 2,500 Canadian and American sail and power boaters who cruise throughout the Great Lakes and their connecting waterways. We are a virtual club with no conventional yacht club facilities. Instead, we focus on collecting and sharing cruising information through our authoritative Harbour Reports. We share knowledge and friendship through informal and organized events like our annual Rendezvous and other Rallies and gatherings around the Great Lakes.

The GLCC is the single best source of information to enhance cruising the Great Lakes. We have over 1,000 reports on anchorages and ports that have been complied by cruisers for cruisers. Our reports, which are available to members, provide detailed information often not found elsewhere. Our on-line curated updating process, driven by member contributions, makes these reports unique among cruising guides resulting in authoritative, accurate and up to date piloting and anchoring information for busy harbours and remote anchorages alike.

The GLCC also operates the Great Lake Cruising Club School offering an extensive curriculum of webinars in the off-season covering cruising destination information, weather, navigation and technical subjects. These popular webinars are open to all but are discounted for GLCC members.

## What To Do With Your Engine Cut Off Switch

As of April 1st, 2021 the U.S. Coast Guard requires that if you are piloting a boat less than 26 feet (7.9 m) in length you are required to use the engine cut-off switches (ECOS) while operating on plane or above displacement speed.

That means wearing a lanyard—aka ECOS link—while at the wheel. Many powerboats and PWC come equipped by the manufacturer with an emergency engine cut-off switch. This safety device can shut off the engine if the operator falls out of the powerboat or off the PWC, or is otherwise thrown from the proper operating position.

In Canada, it is BEST practice while on a PWC to attach the engine shut-off line securely to your wrist or lifejacket or PFD.

Cormorants are in fact a native North American bird with populations throughout the continent. The bird's presence in the Great Lakes has been documented since the mid-20th century and it is likely they inhabited the area before this as well. The species was impacted by the excessive use of DDT and other pesticides starting in the 40's.

With the banning of these chemicals and increased pollution control laws in the 1970's, the Cormorant population was able to bounce back and reoccupy the Great Lakes region.




### 2021: A High Bottom - Low Water Season

- -Summer levels will be like fall/end-of-season. Docking & navigation will be challenging
- -The 12-month dry cycle through April 1st tied for the driest 12 months since 1950
- -A paltry 1.1 feet Min-to-Max total level swing may break the 1.3 foot record
- -The projected 50% chance peak level is only 3-4" above early January!
- -The current level is 13.5" below the average (100-year for May 27th)
- -The IJC's ILOSLR Board just announced further outflow reductions due to water levels dropping below Criterion H14 low water trigger levels

MORE ABOUT TIARA

Who is TIARA, an organization that some confuse with TIA? We're different but complementary to each other. Our mandate is to preserve and improve the Thousand Islands environment. We monitor and support actions and planning that can carry this out. We provide essential information, so people can make decisions promoting a healthy ecosystem. We connect and collaborate with other area organizations supporting a sustainable environment.

TIARA was founded in 1975 following an alarming announcement. With a huge budget, Parks Canada intended to expand its small holdings in the 1000 Islands by taking over 30 square miles of islands and mainland – within five years! Fear of expropriation reminded us how lucky we were to be in a place of world-famous natural beauty. We're now part of a UNESCO biosphere, which says we have "arguably, Canada's greatest diversity of plant and animal communities".

TIARA realized that preserving this unique environment depended on good planning, firmly based on residents' wishes. We persuaded the drafters of our first Official Plan to declare the islands and mainland south of the 401 a Special Policy Area, with guidelines protecting the "ribbon of life" where land and water meet. Ever since, TIARA has worked to uphold this planning.

During the floods of 2017 and 2019, TIARA urged increased outflow at Cornwall, but still acknowledged that no management plan could have prevented the flooding caused by unprecedented precipitation and sudden spring snowmelt. People are beginning to appreciate the value of wetlands in such weather crises. Wetlands act as sponges, holding back rain falling over the whole watershed, allowing it to enter the River gradually. TIARA protests government policies which pave over wetlands for development.

In March 2020, TIARA was planning a workshop on planting shorelines to make them resilient during both flood and drought. We invited other organizations (including TIA) to collaborate with us. The pandemic put plans on hold, but we hope to revive them soon.

TIARA is nominating the Upper St. Lawrence as a Canadian Heritage River. Our nomination document, submitted last June, awaits government approval.

Last September, TIARA joined the national Decibel Coalition, promoting enhanced boat muffler legislation specifying decibel limits.

We're happy to be working with TIA for a safe, beautiful, healthy River.





## TIA- CROSS BORDER TASK FORCE UPDATE

The goal of this committee is to ensure that policymakers on both sides of the border understand that property owners residing across the border are in a unique situation and require special consideration. The simple solution is to have property owners and their families considered as essential travelers and be allowed cross border access in the initial stage of a graduated reopening, subject to appropriate health requirements.

We targeted the Wilson Centre in Washington, D.C., which was supposed to provide guidelines to both governments. Unfortunately, their report has never been made public, but other releases seem to confirm that they supported the concept of special status to property owners.

Several American politicians have advocated strongly for immediate action on establishing a reopening plan. Congressman Brian Higgins (Democratic) and Congresswoman Elise Stefanik (Republican) were strong advocates early on and recently Senator Chuck Schumer has supported fully vaccinated people who have property across the border to be considered essential travelers.

Unfortunately, the Canadian Government remains mostly silent on the issue. Prime Minister Trudeau recently responded to a question of re-opening the border saying, "Perhaps this summer if everything goes well ... now is not the time to travel."

A former Liberal Cabinet Minister and Member of Parliament from Prince Edward Island, Wayne Easter, has co-authored a joint statement with Congressman Brian Higgins, urging their respective governments to develop a plan for re-opening.

Our Committee Member, Stephen Friot, has recently authored a strong letter to Congressman Higgins and Congresswoman Stefanik, through their respective executive assistants Nick Montalbano and Marek Laco. **CLICK HERE** to read the letter.

The Committee will continue to pressure local politicians on both sides of the border to give priority to property owners across the border, and hopefully salvage some of the summer.



# MOTHER NATURE VERSUS TIA SHOAL MARKERS - WHO WINS?

Mother nature takes no prisoners – it can be ruthless, uncompromising, and unyielding with the TIA rock shoal markers. The variables of fluctuating water levels, winds and wave actions create extreme wear and tear on our safety beacons, in some areas of the river more than others. This leaves TIA with the necessity to create a replace reserve fund to an aging inventory approximately 200 rock markers in Canadian SLR waters and providing regular funding to Save the River to help support another 100 shoal markers in US SLR waters ... but at what cost?

The life of a shoal marker is uncertain but. assuming a 5-year average life span, here is some hypothetical math. Based on a capital cost of \$350 for one marker, connection chain and cement block anchors this equates to \$70 per year straight line depreciation. Add to that another \$80 per marker to place in the spring and remove in the fall. Multiply that by 200 markers and TIA has a \$30,000 per year financial operating liability for the Canadian St. Lawrence River side excluding its support to STR and excluding the other fixed costs of the organization such as insurance, communication platforms, events, and other programs.

## **Fraud and Floods**

Change can be scary, especially in times like these. This policy sometimes requires a 30-day period before becoming effective so don't wait if you are worried about flood damage to your property.

With so many unknowns in the universe, don't let insurable risks add undue stress to your life. We urge you to take the time to go over potential hazards with an insurance professional today, even if we are not your agency of choice.
